The Mexican American Bar Foundation ("Foundation") proudly announces the opening of the application season for its annual scholarship awards program. Since 1991, the Foundation has pursued its mission of removing barriers to opportunity and success in the legal profession by awarding scholarships to law students.

ELIGIBILITY APPLICANTS MUST MEET THESE REQUIREMENTS TO BE CONSIDERED

Eligibility is limited to matriculated law students who: (1) currently attend and are in good standing at ABA-accredited law schools in the City of Los Angeles (Loyola, Southwestern, UCLA, and USC); and (2) will be enrolled in such law schools during the 2026-27 academic year. Applicants are required to inform the Scholarship Committee if they intend to or have applied to transfer to a school that is not included above. We regret we do not have the resources to award scholarships to students who are not attending the law schools indicated above.

SCHOLARSHIP SELECTION CRITERIA

In evaluating scholarship applicants, the Foundation's Scholarship Committee considers the applicant's financial need, academic achievement, community service, leadership and life experience, personal statement, interview, and whether the applicant was a first-generation college student or will be a first-generation graduate student. Scholarship amounts will depend on available funding with the goal of awarding scholarships up to \$10,000.
